REGULATIONS FOR INTERNAL MEDICATIONS:

School Nurses, Principals and School Personnel are constantly being asked to dispense internal medication including Tylenol tablets, cough syrup, and ibuprofen to school children. Compliance with such requests is contrary to regulations as outlined in the NURSE PRACTICE ACT and provisions of the State Education Law. If a parent submits a written request from a physician which indicates the name of medication, dosage, route, frequency, and time to be given at school, only then is the school nurse permitted to administer medication. The medication must be brought to the Nurse's Office by a parent/guardian and **MUST** be in the original pharmacy container.
